- We indemnify: Reece against all loss, damage, costs and expenses arising from any failure by the Customer to meet any Obligation(s) when due, including all costs and expenses related to the enforcement of our obligations under this Agreement.
- 8. We Jointly and Severally Agree: (a) although as between Customer and us we are a guarantor only, nevertheless as between Reece and us, we are and shall be deemed to be a principal obligor for the due and punctual performance of any and all Obligations; (b) to pay to a stake-holder nominated by Reece the amount Reece certifies is payable by the Customer to Reece before being entitled to dispute whether or not that amount is payable; (c) that this Agreement shall remain effective and we shall not be released from liability notwithstanding any granting of time or other indulgence or concession to the Customer, any forbearance or any other conduct or event (including any arrangement or deed of company arrangement whether or not agreed to by Reece) which but for this clause may have released or varied any obligation of the Customer, and/or any of us under this Agreement, and this Agreement shall be and remain a continuing guarantee for performance of any and all Obligations unless and until this Agreement is released by Reece in writing; (d) that any payment of any Obligation(s) which is subsequently avoided by any law relating to insolvency shall be deemed not to have been paid; (e) any and all monetary Obligations not recoverable from us as a guarantor (whether by reason of any legal limitation, insolvency, disability or incapacity on or of, the Customer or by reason of any other act or circumstance whatsoever whether known to Reece or not), shall nevertheless be recoverable by Reece from us as sole or principal debtor; (f) that we sign both in our personal capacity and as trustee of every trust of which we are trustee (if any); and (g) to notify Reece within seven days of any change in the Customer's structure, management and/or position including: (i) any sale or disposition of any part of the business of the Customer, (ii) any change in director, shareholder, management, partnership and/or trusteeship; (iii) any new mortgage and/or security given to any supplier and/or financier, and (iv) any involvement in
- 4. Waiver: As between Reece and us, we waive all rights (whether of subrogation or otherwise) as surely, legal, equitable, statutory or otherwise and agree to accept liability for the performance of any and all Obligations as if we were primarily liable for performance of any and all Obligations.
- 5. Charge: We grant a security interest (as defined in the PPSA) in all our Personal Property and a charge over all of our Non-Personal Property in favour of Reece for the punctual performance and observance of all of our Obligations. The charge over Non-Personal Property is a fixed charge. The security interest in accounts receivable shall take effect as a transfer. We will, whenever requested by Reece, do or cause to be done any thing or execute any document to effectively secure or protect our property and the security interests, charges, and priorities provided for in this Agreement, including the execution and delivery of a registrable mortgage over interests or estates in any land in which we now have any legal and/or beneficial interest and/or in which we later acquire any such interest. To the fullest extent possible, we waive our rights under the PPSA and agree that sections 114(1)(a), 117(1)(c), 133 and 134 of the PPSA will not apply.
- 6. Consideration: Reece agrees to grant credit from time to time at Reece's discretion to the Customer and/or to forbear from taking any legal action against the Customer for one (1) month from the date of this Agreement. In consideration of the foregoing, we agree to indemnify, and provide a guarantee to Reece, on the terms and conditions of this Agreement.
- 7. Governing Law: We agree that this Agreement and any claim or dispute between Reece, the Customer and/or any of us shall be governed by New Zealand law and we agree to submit to the exclusive jurisdiction of the New Zealand courts.

- 8. Guarantors: Where we comprise more than one person, each of us agree to be jointly and severally liable under this Agreement for the performance of all Obligations. This Agreement shall be binding on our executors and administrators and shall be enforceable notwithstanding the receivership, winding up, liquidation, dissolution, death, bankruptcy or insolvency of the Customer or us.
- 9. Liability unaffected: Reece may make any arrangement and/or compromise with any of us, obtain additional guarantees, indemnities and/or securities from any party and/or release and/or compromise with any of us and/or any other party without affecting our liability to Reece. Neither Reece nor the Customer is required to sign this Agreement.
- Credit Limit: Any credit granted by Reece to the Customer is at Reece's discretion and shall not limit our joint and several liability to Reece.
- 11. Privacy Act: We HEREBY CONSENT to Reece (subject to its obligations under the *Privacy Act* 1933 and the *Credit Reporting Privacy Code* 2004): (a) collecting, holding and/or using personal information about us until the Customer has paid all amounts due to Reece and Reece has ceased to provide credit to the Customer ("Credit Period"): (i) from credit reporters or any other source (including other credit providers or our advisors) which relates to but is not limited to our identity, credit history and/or solvency; (ii) for the purposes(s) of assessing creditworthiness, risk and/or solvency and/or enforcing any of Reece's rights and any other directly related purposes ("Credit Purposes") and we authorise each such source to disclose such information to Reece; and (b) disclosing any such information during the Credit Period to: (i) advisors or agents of Reece, other credit providers, debt collectors or any other persons for Credit Purposes, to confirm such information or to create profile; and (ii) to credit reporters for collating with other information about us from other sources or for creating a credit score and making the foregoing available to other credit providers. Reece may refuse to grant credit if any information to which it is entitled is not provided. Reece agrees to allow us access to, and correction of, all personal information it holds about us. This Agreement may be produced as conclusive evidence of our consent pursuant to this clause 11.
- 12. Severability: Any part of this Agreement which is held to be invalid, illegal or otherwise unenforceable, shall be severable without affecting any other part of this Agreement.
- 13. Acknowledgement of current debt: We acknowledge that the Customer is indebted to Reece in the sum noted below as at the date noted below and we acknowledge and agree that our guarantee under this Agreement is unlimited.

To the fullest extent legally permissible all dealings between Reece New Zealand Limited [Reece] and any Customer relating to any products supplied by Reece to the Customer being plumbing hardware and associated construction materials ["Products"] and/or services are subject to the following terms and conditions of trade ["these Terms"] unless Reece agrees otherwise in writing:

- Payments: The customer shall make all payments by cash, cheque, bank cheque or EFTPOS and without set off or deduction unless otherwise agreed in writing by Reece. The customer shall pay for Products supplied on or before delivery, except where Reece has agreed in writing to provide credit to the Customer, in which case the due date for payment will be the 20th of month following the date of invoice. If any payment is made by credit card Reece reserves the right to charge an administration fee equivalent to 2.25 percent of the payment.

  Interest: Without limiting any other provision in these Terms, interest will be charged on overfue accounts on distribution from the distribution.

- Property: Even if Reece grants any credit facility and/or time to pay: 3.

- Severability: Any part of these Terms being a whole or part of a clause shall be capable of severance if held to be illegal, invalid or otherwise unenforceable without affecting any other part of these Terms, which shall remain in full force and effect.
- Goods and Services Tax (GST): The price for Products supplied shall unless Reece otherwise specifies in writing be exclusive of GST and/or any other applicable taxes, government charges, levies and/or imposts of any kind whatsoever - any and all of which must be paid by the Customer to Reece as and when and in such manner as Reece reasonably requires
- Warranty Policy: Save and except as required by law no warranty in relation to the Products is given where Reece is not the manufacturer of Products other than any warranty offered by the manufacturer as provided under clause 5(c) of these Terms, and to the fullest extent legally permissible Reece's liability shall in all cases be strictly limited in accordance with clauses 4 & 5. of these Terms. Unless otherwise required by law, where Reece is manufacturer of the Products then the Reece Standard Warranty applies for the period applicable to the relevant Products. Details of the Reece Standard Warranty and the schedule of periods applicable are available upon request from Reece's Head Office at 134 Wellesley Street, Auckland.

#### Waiver and Changes to Terms:

- Reece may amend these Terms from time to time by written notice to the Customer and the amended Terms will apply to all orders and supplies of Products after such notice is given. No other changes may be made to these Terms without Reece's prior written consent.
- Reece's failure to enforce or delay any part of these Terms will not be deemed a waiver of these Terms unless agreed in writing by Reece.
